USCF RACES:

- June 4/5 Tour of Garland, Texas
- Sat. Garland, TX. 1st stage of 3 stage race. Jay finishes in a group of 3 after 83 miles in 100° weather. He is in 10th place overall. 1 1/2 hours later the Time Trial begins. Jay salvages himself and places 3rd in the T.T. this moves him up in the standings to 8th place.
- Sun. 3rd stage a criterium .8 mile course with 4 180° turns 6 90° turns. The heat is again near 100°. Jay finishes 6th to retain his 8th place overall standings. This in spite of a flat before the start and riding someones spare real wheel with an Clement Eluisia tyre.
- June 12 Aurora, Illinois

 ${\operatorname{CAT}}$ IV - Bob Pattison gets separate from the main pack on the second lap, and never regains contact.

CAT II & III - Doug Bertram and Steve Berger get dropped. Paul Henderson and Jay Manthey provide a driving force and were in several breakaways. Jay in one with 5 laps to go with a Michigan rider. They collected several primes and gained 15 sec. on the pack. Unfortunately they were caught on the last lap, and Jay claims dirty tactics in the final sprint. Paul led out the sprint and grabs 2nd place. Jay was stuck back in 13th.

- June 18 State T.T. Championships, GreenValley, IL

 Thank you to everyone who made this event possible. We could not have done justice
 to the event without all the help we received. Only 4 IVW riders participated. Paul
 Henderson takes 6th overall and Jay Manthey 7th. Steve Berger and Chris Huggins
 finished beyond the qualifiers.
- June 19 State Road Race Champions, Heritage Lake
 A KILLER course with plenty of heat. Jay and Paul finished 8th and 10th respectively.
 7 qualifiers only to go to Nationals for each championship event.
- July 2 DeKale Time Trial (25 mile)

 Jay starts out with a fabulous half of 28 min., and is really flying on the way back when with 1 1/2 miles to go he james his chain and breaks it, also bends his chainwheel. With riders passing him that he had passed on the way out, he is running toward the finish, then borrows a bike with 3/4 mi. to go from an old lady riding along the course. He finished with a time of 1:03:15. He asks for a restart and cuts a minute off that time, and places 5th. Steve Berger places 2nd in the CAT III division, down by 22 seconds from the leader.
- July 4 Freeport, IL

 Jay won this race last year with a solo breakaway. This year with 44 miles to go
 some people were saying "not again!" He was caught eventually by a lone rider, and
 they both lapped the field. Jay fades and finishes second, Paul Henderson 5th,
 Steve Meismer, Steve Berger, Rich While did not finish. In the CAT IV event Chris
 Huggins and Bob Pattison start out in the back of the pack. As we watch we start
 counting the loss when, on the next lap, they have both moved foreward into the pack.
 With the pack breaking up however, it looked like it was too late. In the following
 laps Chris makes the break by briding some huge gaps by himself, sheer willpower,
 and legpower. He finished last in the group finish but that is good enough for 8th
 place. Bob Pattison wasn't so luck in making the breaks and finished behind the field.


