
It was suggested that these people fill at least a 1 year term. If they choose to end their terms after 1 year, they should notify the President in writing at least 2 months before the term ends.





### YOU CAN HELP MAKE BICYCLING SAFER IN THE CITY

On Easter Sunday, March 26, 1989, I was the unfortunate victim of an encounter with a storm sewer grate. While contending with traffic, I accidentally dropped the front wheel of my bicycle into a storm grate at 17 MPH. Needless to say, I became air borne, and the landing on concrete was rough. Fortunately, I was wearing my helmet! I sustained a severe cut above the left eye and scrapes and bruises on the face, the left shoulder, both wrists, and sprained my right knee. There were no broken bones.

On Tuesday, March 28, I visited Mayor Maloof's office. The secretarial staff was a little shaken by my appearance. This prompted a call from the mayor to discuss the hazards of the storm sewer grate situation in our city. He asked that I try to document other accidents and injuries from bicycle encounters with storm sewer grates. The majority of the grates in the city are not bicycle safe because the slots run parallel to the curb in the direction of travel.

Accordingly, I need your help! If you have at any time had a bicycle accident due to a storm sewer grate, please provide your name, address, phone number, the date and location of the accident, and a description of your injuries and / or damage to your bicycle. Contact Peoria Bicycle, Vitesse, or Illinois Cycle in Peoria, or Russell's Cycle World in Washington, Illinois.

Thank You! With your support, we may able to demonstrate to our Peoria city government and that of neighboring communities the seriousness of this problem.
