# **Pekin Trails Ahead**

The Pekin Park Board held a hearing March 8 to gain public input on plans by design consultants Scruggs and Hammond to create a recreational trails system in Pekin's Mineral Springs and Cole Miner's Parks. Proposed plans are for 10-foot-wide paved trails within the two parks.

The Pekin Park Board's main goal is to create facilities which appeal to the greatest number of people. Members of the board feel that improved in-park facilities will attract more park users and establish a base of support for future trail expansion. The IVW, invited to the meeting by the board and represented by Pekinite Bill Clark, agreed that in-park trails would serve the needs of new riders and families with

children, but stressed the need to define and improve routes which feed the park and other significant Pekin destinations. The club went on to offer its knowledge to the board and Pekin city government in reaching this more ambitious goal.

Pekin-wide bicycle planning would represent a significant addition to Tri-County planning already underway in Peoria. With that in mind, the club gave the park board a draft copy of the Peoria map for review.

Members of the Illinois Valley Striders, Peoria's running club, also supported improved access to the larger trail/road network for runners and walkers.


# The Season Begins...

SUNDAY, FEBRUARY 20. Rob Alexander: Eleven riders showed up on a cloudy day for a short loop on country roads around Washington. At the end of the ride, the group took advantage of Russell's Spring Preview to get a free snack and do some looking around. Overcast, damp feeling. 38°. Very light northwest wind.

SUNDAY, MARCH 6. It is rumored that if you build the perfect day, the riders will come. As far as I (Bob Alexander) know, none of the riders present wanted to take credit for building the day, but 26 showed up. Energy levels varied from Jennifer chasing Bob and Paula's tandem for 17 miles to the six riders who rode 14 miles at an easier pace. The main pack cruised along for almost 20 miles and everyone worked up an appetite. After the ride we had a little snack of Mexican food and a nice visit with friends. There is talk of another feeding frenzy later in the year. Suggestions for the theme are welcome. 57°. West wind, 0–5 mph.

SUNDAY, MARCH 13. After crossing the new Michel Bridge, Steve Grube and 18 riders cycled to Bartonville and then across the Pekin bridge. After lunch at Hardee's the group returned to East Peoria. 50°. NW wind, 5–10 mph.

SUNDAY, MARCH 20. Six IVW members rode from Morton to Hopedale. Peggy Tresenriter, leader. "Beautiful day to ride! Lots of headwind, lots of tailwind and a scenic tour of the Mackinaw River Valley. Check out that temp!" 65°, SE wind, 20 mph. Second ride, same day: Road Riding 101, led by Alexander and Camp, attracted 26 people to Washington. 58°. ESE wind, 10–15 mph.

# **Commission Discusses Bicycles**

During a March 3 meeting, members of Peoria's Traffic Commission discussed two bicycle-access issues: Mt Hawley Road/Kellar School and the Peoria bicycle route map.

Mt. Hawley Road: As reported by IVW

member Jim Wittmer in the March newsletter, options for reducing traffic by Kellar School are being considered. Options include possibly closing the south end of the road at Knoxville Avenue. Thanks to a letter lim wrote after a public hearing on the matter, bicyclists' needs will be considered ADVOCACY along with other traffic concerns. More public meetings on Mount Hawley are planned as engineers and the public

focus on the best design option and discuss the method and amount of financing.

Note: The first public hearing generated a lot of hostility on the part of affected residents of the area. At press time, Jim was the only resident who had followed up the hearing with a letter to city officials. His letter, which calmly outlined key points about the project, did not go unnoticed. Peoria Traffic Engineer Jim Baumann responded to Jim's letter with a phone call.

Peoria Bicycle Map: Engineer Baumann told the Traffic Commission about the ongoing work with the IVW to develop Peoria's portion of a Tri-County bike map. The map should be ready for release this summer.

Other Meeting News: I met Mel Olejniczak who represents railroad interests,

the local trucking industry. Truckers like roads with wide outside lanes, too. I feel another door opening.

PEORIA TRAFFIC SEMINAR FEATURES

BICYCLES. Traffic engineers from throughout the Midwest attended an annual traffic engineering seminar in Peoria on March 24 and 25. Peoria's

Traffic Engineering Department and the Illinois Department of Transportation organized the two-day event which featured two speakers on bicycle issues. George Drye, of Bloomington, spoke on Bloomington/Normal's Constitution

Trail. Joan Berry, of Chicago, discussed bicycle parking issues. Berry should know her topic; Chicago has used recent ISTEA\* grants to create a very large and popular bike-parking program.

\*Intermodal Surface Transportation Efficiency Act. Signed by President Bush in 1991, ISTEA recognizes bicyclists and pedestrians as part of the nation's transportation mix. ISTEA funds are distributed by the states to qualifying transportation enhancement projects.

Seems to me we have a really cushy life here in the Midwest. After all, we've got relatively modern, narrow-laned, trafficcongested streets that present no real challenge to cyclists who want to leave their

beloved sidewalks, but the situation is not completely hopeless.

If you want something a little more challenging, you could be riding the historic roads of Massachusetts and run smack dab into more than pioneer democracy at every turn. Yup, ever since Paul Revere galloped over some chickens on his way to the Olde North Church, the roads around Boston have enjoyed, well, a certain reputation. One look out the cab window on the way from the airport-at a 45-degree angle as you grab for your

seat and/or door handle—is convincing evidence that riding around history-town might be the maniac adventure you've always dreamed of.

Mr. Charles G. Thomas of Cambridge obviously knows this and is not wasting his time on bicycle-friendly streets or bike trails. Charles is taking the law into his own hands,

literally. Massachusetts law permits any resident to submit a bill to the legislature for consideration. His bill, H733, requires that every person operating a bicycle in the state of Massachusetts obtain bodily injury liability

insurance of at least \$20,000. If a person fails to do so, he or she shall be subject to a fine of between five hundred and five thousand dollars, or imprisonment of up to one year. Parents of minors are made liable for damages negligently caused by their minor bicyclists. After all, the kids gotta have fun, too.

But then, he's also the one who introduced a bill requiring that all auto insurers make available uninsured and underinsured motor vehicle coverage to persons who are neither

motor vehicle owners nor passengers. Now I wonder who he means? Skateboard and grocery cart owners? Considerate guy, Thomas. He's going to make sure that cyclists get their money's worth playing Boston bumper pool with their big petroleum-sucking cousins and still be covered.

Hey, give Charles a break. He probably

cycle-commutes to an insurance company on the verge of massive layoffs and is looking for a little job security as well as physical security, so you can't blame him. After all, those bicycle premiums could bring in another million or so, easy.

So we should thank our lucky stars that we live in good 'ol Illinois, where we let our intelligent politicians and city officials make the laws for us and don't pay any attention to insurance companies looking for fertile, untapped new markets. Our local hordes of motorized vehicle drivers are well behaved and won't mind sharing the roads with increasing numbers of their two-wheeled uninsured cousins, secure in the knowledge that they'll never get totaled by a couple of 1inch tires and that if their lawyers have granite sidewalks, their policies must be elastic enough to cover the neighbor's uninsured cat. And if we want more adventure, we can just forget the streets-in time, they'll provide more thrills.

Darn. Charles' bill will probably be tabled until the next century. And I was looking forward to bringing my bike to Boston next time. At least if I didn't make it back home, my beneficiary would clean up nicely.

LEAGUE OF AMERICAN WHEELMEN CHANGES NAME. According to Advocacy Chairperson Eric Hutchison, it's official: After more than a century under the old name, the League of American Wheelmen is now known as the League of American Bicyclists. After board members approved the new name earlier this year, ballots were sent out to all of the organization's members. And LAW members voted 5

to 1 in favor of the new name.

The IVW is affiliated with the League, and a number of IVW members are also LAW/LAB members.

Membership in the national organization also means automatic

membership in the League of Illinois Bicyclists, the state-based arm of the League.

Don't expect references to LAW to die out anytime soon. While the group will now promote itself to the public as the League of American Bicycles, the Wheelmen name may still be used in internal publications. And then there's the matter of those thousands of patches that are already printed . . .



AND NOW FOR SOMETHING COMPLETELY DIFFERENT. I almost pitched the envelope when it arrived in my mailbox: Adventure Cycling Association . . . hmmm, sounds like another well-crafted attempt to separate me from my hard-earned money and send me on the cycling vacation of a lifetime. Well, kinda.

Actually, it was another American institution in the throes of a name change, this time Bikecentennial. According to the letter I received, "after 20 years with a name inspired by our involvement in America's 200th birthday celebration in 1976, we've chosen a name that better describes what we're doing today—helping cyclists use their bicycles for adventure, exploration and discovery."

On the back of the letter was a list of affiliated bicycle clubs. On the list from Illinois: Arlington Heights, Aurora, Blackhawk, Evanston, Folks on Spokes, Jacksonville, Joliet, McHenry, Oak Park and our next-door neighbors in Canton, the Spoon River Wheelmen. The IVW is not currently affiliated with ACA.

Funding May Be A Gas In California. From Internet: California SB 1567 (Senator Lucy Killea, I-San Diego) would appropriate \$1 million from the Petroleum Violation Escrow Account to Caltrans to fund capital expenditures for bicycle transportation projects. This bill is sponsored by the new California Bicycle Coalition.

The Petroleum Violation Escrow Account (PVEA) was established through settlements and court judgments against oil companies found to have violated Federal price-fixing regulations. Funds from this account are disbursed by the Federal government to the states to be used for projects that will reduce reliance on oil or for the establishment or

expansion of energy conservation programs. Traditionally, California bills that allocate PVEA funds have been held in the Assembly Ways and Means Committee, subject to negotiations between the Legislature and the Governor.

Alan Wachtel of Palo Alto, CA, who posted the previous computer note on California bicycle project funding, is the Government Relations Director of the California Association of Bicycling Organizations (CABO), and State Legislative Representative for the League of American Bicyclists (formerly League of American Wheelmen). "My mother is from Peoria. My grandparents lived at 811 East McClure Avenue, where I visited many times, and two of my grandmother's brothers and their families also lived in Peoria. Just about everyone is gone now. My cousin's son, Steve Parks, just graduated from Bradley, although his family now lives in Minneapolis."

# Relativity Revisted...On Tandem

My wife and I have a bet. She says that the back of the tandem (where she usually rides) goes faster than the front. I say that's crazy; the front goes faster because it's always ahead of the rear. Who's right?

#### -Challenged Chuck El Paso

This question is tougher than it first appears to be. Obviously your argument makes a great deal of sense: The front is faster because it is, well, in front.

However, it could be that the front only appears to be faster because the rear is pushing it out of the way. In any case, it is unlikely that both ends of the tandem are traveling at the same rate, because you would end up sitting beside your wife, not in front of her.


I suggest the following experiment: The next time you take your tandem out, squeeze the rear brake ever so lightly. If the tandem slows down, it's because the rear wheel has to overcome the additional drag of the brake. At that point, the rear of the bike can no longer push the front (if, indeed, it does at all). But don't jump to a hasty conclusion. Release the rear brake and lightly apply

the front brake. After a few seconds, assess your situation: Are you in front of or behind your wife?

If you feel that this test isn't conclusive, attempt to ride the bicycle backwards. If your wife doesn't feel comfortable with this part of the test, you may treat that as conclusive proof that the

front of the tandem is indeed the faster.
