

Yes folks, popular rumor has it that there are, in fact, paved, lightly traveled, and scenic (yes, I said scenic) bicycling routes hidden right here in our midst. I am interested in compiling a series of favorite IVW bicycling route maps. These maps will be published in the newsletter (see the enclosed first entry) and printed in mass to be sold at local bike shops. I see these maps serving several significant needs:

- \* Acquaint bicyclists new to the area with good routes.
- \* Share the news of good touring routes among bicycling veterens in the area.
- \* Give IVW ride leaders (especially potential ones) some basic guides to work with.
- \* Enhance local interest in bicycling as legitimate and enjoyable recreation.
- \* A visibility and fund raiser for the IVW.

Now the pitch...

Who better should know of the local gems of two-wheeled-touring-tranquility than the members of our favorite local bike club? Here's the basic map ingredients I feel are important:

- \* Starting locations within 2 hour drive of Peoria (At least for the first maps).
- \* Interesting things to see and places to "refuel". (The second best thing about biking is eating.)
- \* I'm not just intersted in rural routes. If you know of good (or fairly good) in-town routes, let's hear them.

Please contact me with your ideas. You don't need to prepare a full-blown map (although I won't turn it down). A sketch or even a phone conversation will do. (Don't be afraid of my answering machine. It won't bite....to hard.)

### JUBILEE PRINCEVILLE LOOP

### 25.2 MILES

The starting point for this route is Jubilee College State Park (14 miles NW of Peoria off Route 150 309/243-5441). This park is a featured turning point of many IVW evening rides. The park not only has the basic bicyclists' necessities (water/restrooms/parking) but also features camping, picnicking, or for the part time hoofed cyclist, equestrian trails. An Olde English Faire featuring medieval music, warriers, and craftsmen is held at the park in June. The alternate route through the park (--x--x--) has some mud and gravel but is very scenic (ideal for mountain bikers). This road meets the entrance to the park to the east of the parking lots.

Several intersections on the route are unmarked so watch your odometer or count cross streets. Beware of the "S" intersections of MENDENHALL ROAD and PARKS-SCHOOL ROAD. The jog off of parks-school is easy to miss.

Princeville is a comfortable little town to strectch the legs and refuel. (The Buster Bars at The Whip come highly recommended.)

A.M. ride, Mo Kelly and Peggy Tresenriter both hit the same dog while riding home From Mackinaw. I urge anyone having a severe problem with a particular dog to contact their County Animal Control Unit. There are laws holding owners responsible for their dog's actions. I was bitten in 1983 and broke a pump extricating the dog from my leg. I contacted the Tazewell County Animal Control Board and they handled everything. I was reimbursed for my pump by the owners and received a nice note of apology.

# Sam sez


